**Tuesday, June 27, 2023**

**Opening Eucharist**

The Forty-third Session of the General Synod commenced with a Eucharist service from 7:00 to 9:00 pm MDT in the McEwan Hall of the University of Calgary, Alberta.

**Land Acknowledgement**

The Most Rev. Linda Nicholls acknowledged that the Diocese of Calgary sits on traditional territory of the First Nations of the Treaty 7 region in southern Alberta, including the Blackfoot Confederacy, which comprises the Six and Kainai Nations, as well as the Tsuut'ina Nation and the Stoney Nakoda, including the Chiniki, Bearspaw, and Wesley First Nations. Additionally, she acknowledged the presence of the Métis Nation of Alberta Region 3 within the city. The acknowledgment highlighted the historical significance of the land, previously inhabited exclusively by Indigenous peoples, and concluded with prayers for respect for the land and reconciliation among all inhabitants.

## **Evening Session**

### **Call to Order**

### **Extending Privileges**

The Most Rev. Linda Nicholls asked the General Synod to provide privileges for The Rt. Rev. Sidney Black, along with his wife, Melva Black, and their daughter, Erin Black.

### **Anglican Council of Indigenous Peoples (ACIP)**

The evening commenced with The Most Rev. Chris Harper, National Indigenous Anglican Archbishop, extending a warm welcome to General Synod and all Indigenous relatives, inviting their participation in an onstage circle. Addressing the complexity of Canada Day, he acknowledged the nation's history of racism and remarked on the need for a deeper understanding of Canadian history. The significance of *The Covenant and Our Way of Life*, two pivotal documents ratified at the most recent Sacred Circle, was discussed, rooted in the legacy of Elders and signifies a new phase of action and governance for the self-determining Indigenous Church. The growth of Indigenous ministries and their vibrant community engagement was celebrated, despite challenges. Deep appreciation was expressed for the dedication of Indigenous clergy and the ongoing support of the Anglican Church of Canada and the Evangelical Lutheran Church in Canada, urging continued collaboration and celebration of shared successes.

### **Sacred Beginnings**

Video highlights from Sacred Beginnings, a youth gathering of Indigenous Anglicans were presented. The Rev. Dixie Bird and Ms. Yolanda Bird, youth leaders from the Montreal Lake Cree Nation on Treaty 6 Territory in Saskatchewan, elaborated on the purpose of Sacred Beginnings, influenced by their colleague the late Rev. Canon Dr. Ginny Doctor, Indigenous Ministries Coordinator. They described it as a dream aimed at empowering youth

to reclaim their traditional teachings and engage in gospel-based discipleship. The program offered a range of educational opportunities, including mental health awareness, traditional teachings, and spiritual practices. Ms. Nadia Sinclair, youth delegate from Chemawawin Cree Nation, Diocese of Brandon, highlighted how Sacred Beginnings, held in Beauséjour, provided crucial insights into Indigenous culture, a knowledge gap she experienced growing up on the reserve and expressed gratitude for the opportunity to learn about intergenerational trauma and connect with other youth who shared similar experiences. She concluded her remarks by underscoring the significance of such gatherings in fostering a sense of community and solidarity among Indigenous youth.

### **Sacred Circle**

Video highlights from the recent Sacred Circle were presented. Co-Chairs, The Rev. Dr. Murray Still and Rosie-Jane Tailfeathers, reflected on the Anglican Council of Indigenous People's achievements like the development and translation of *The Covenant and Our Way of Life* documents, pivotal for Indigenous ministries, along with key Indigenous appointments. The first in-person Sacred Circle since 2018 provided crucial opportunities for spiritual growth and community building, with Archbishop Christopher Harper's installation marking a milestone during the gathering. The Rev. Grace Delaney shared reflections on Sacred Circle, highlighting its significance as a time of reconnection with ancestors and spiritual awakening. Bishop Lydia Mamakwa also recalled its importance in shaping the direction of Indigenous ministries. General Synod was encouraged to support these efforts and offer prayers for the community's journey forward.

- 1) The Primate and the National Bishop to respond to opportunities for solidarity and advocacy, including responding to specific incidents of human rights violations;
- 2) Our churches to seek ways to provide safe spaces in Canada for conversation and collaboration in pursuing truth, and working for a just and lasting peace among all people of the region;<sup>27</sup>
- 3) Our churches to decrease the presence and impact of Christian Zionism<sup>28</sup> within our denominations while discerning ecumenical and civil society possibilities for greater interaction with Palestinian Christians and those of the Muslim and Jewish faith who seek a just peace in the region;

  - d) be open to opportunities for accompaniment, advocacy, and action; and
- 6) The General Synod Office and the National Office to
  - a) examine, discuss, and address emerging realities, including the implications of the recent reports by B'Tselem, Human Rights Watch, and Amnesty International, and for its governing bodies to respond appropriately;<sup>29</sup> and
  - b) continue to support the Evangelical Lutheran Church in Jordan and the Holy Land and the Episcopal Diocese of Jerusalem in their deep capacity for and implementation of programs that serve the needs of local communities and peoples.

We affirm the rightful place of the State of Israel in the community of nations and recognize its legitimate security needs. We affirm the State of Palestine and its right of self-determination and legitimate security needs. We condemn the Israeli blockade of Gaza, and the occupation of East Jerusalem and West Bank since 1967, including settlement construction and expansion in these territories, as illegal under international law and must be ended. We believe it is only through an end to the occupation and a just, comprehensive and lasting peace settlement that the security of both Palestinians and Israelis can be assured.<sup>30</sup>

We affirm that our work concerning Palestine and Israel is guided by principles for human rights and peace,<sup>31</sup> including:

- Respect and assertion of human rights and dignity for all
- Commitment to International Law and International Conventions
- Equality including gender justice and racial justice
- Commitment to challenge Christian Zionism,<sup>32</sup> anti-Semitism,<sup>33</sup> and Islamophobia<sup>34</sup>
- Non-violence
- Ending political and religious extremism
- Self-determination
- Commitment to advocacy and action

We affirm the need to listen to the Patriarchs and Heads of Churches, and repeated pleas of the Christian

communities of the region, and to accompany them in prayer and action.<sup>35</sup> This includes our primary partners, The Episcopal Diocese of Jerusalem and the Evangelical Lutheran Church in Jordan and the Holy Land.

We join the World Council of Churches in recognizing that Israeli discrimination against Palestinians is overt and systemic. The ongoing half-century-long occupation continues to contradict the human dignity and human rights of Palestinians living under this system of control, while the response of the international community to this travesty continues to fail. The 2022 suppression of several Palestinian human rights organizations by Israeli authorities without much effective opposition by the international community is an emblematic example of this system of control and failings. For Palestinians, the situation is sadly compounded by the grave divisions and inadequacies of the Palestinian authorities, including reprisals against opposition leaders and the lack of legal and democratic accountability.<sup>36</sup>

We affirm the advocacy concerns identified by Canadian church members in the 2020 KAIROS *Palestine and Israel Delegation Report*.<sup>37</sup>

- Canada has a strong policy base to take leadership and support local women's peace building initiatives as reflected in the Feminist International Assistance Policy (FIAP) and National Action Plan of Women, Peace and Security. We urge Canada to take leadership on these issues and to implement these policies in the government's work in Palestine and Israel.
- Canada has articulated a strengthened commitment to support and defend human rights defenders in the recent policy, Voices at Risk: Canada's Guidelines on Supporting Human Rights Defenders. We welcome this new policy and call on the Canadian government and its Embassy and Office, to fully implement these guidelines in its relations with, and development in, Israel and Palestine.
- Canada's efforts to promote international human rights includes strong commitments to protecting the human rights and safety of children and youth. We urge Canada to closely monitor and report on the treatment of Palestinian children arrested by Israeli forces and prosecuted in the Israeli military court system, and on the increasing numbers of Palestinian children killed by Israeli soldiers in the occupied territories where a climate of impunity and an almost total lack of accountability persists.
- We urge Canada to take a lead in supporting the right to self-determination on the ground in Palestine as we recognize and continue to address the right of Indigenous Peoples to self-determination in Canada and globally.
- We urge Canada to take leadership in the international community to end the blockade on Gaza and ensure residents have immediate access to humanitarian assistance and freedom of movement, while affirming the necessary conditions to address Israel's legitimate security concerns.
- We call on Canada to increase funding to UNRWA which provides essential services to millions of refugees, including those in Gaza where 70 percentage are refugees of 1948.<sup>38</sup> In 2020 the Canadian government announced a 3-year, \$90 million commitment from 2020 through 2022,<sup>39</sup> but this funding is not increasing rapidly enough to fill this critical gap. We urge Canada to give \$50 million annually to UNRWA, matching Norway's contribution based on GDP.
- We call on the Canadian government to continue to take a just, constructive, and human rights- based approach on Palestine-Israel issues, taking into account the extreme imbalance of power between Palestine and Israel and in line with international law and official Canadian foreign policy.
- We urge the government of Canada to live up to the entirety of its existing policies on peace in Palestine and Israel, and to its commitments to International Law and International Conventions.

### Primal Address 2023 GS – Calgary

Greetings to members of General Synod, visitors, and to our special guests, especially Bishop Anthony Poggo, General Secretary of the Anglican Communion; & Bishop Franklin representing The Episcopal Church.

#### Being the Church!

I want to begin my address with a reflection on who we are as Anglicans – and part of the church of Jesus Christ in the world. For everything we will decide here about our life as a church begins with knowing our roots.

As Anglicans we are a diverse gathering of women, men and young people, from a wide variety of backgrounds and experiences . . . Indigenous people, descendants of early settlers, and relative newcomers . . . dispersed in a wide array of settings and circumstances, urban, suburban, rural and isolated, from coast to coast to coast. All have been called into a relationship with God through Jesus Christ by baptism!

Around us we see many models of “being church.” Some are independent individual congregations, where decisions are made for that particular gathered community by that community alone. Others belong to denominations where key decisions are made centrally and apply to everyone around the world. Still others are in between, with some commitments made locally and others requiring broader consultation.

There is much about church life that finds its roots in the gatherings of the synagogue, or the civil structures of Roman life, or the political realities of the early Christian communities, or subsequent schisms – and tangentially in the Gospel itself. There can be many ways to live out the core principles of the faith in community. What are the assumptions, principles and values that we share as Anglicans, and commit to together?

Of course, we believe that our particular form of “being church” is the best for us. We need to know and understand those things that are particularly Anglican, the basic principles that undergird and shape our common life. They are worth naming again, and committing ourselves to them, so that the life we envisage for our Anglican Church of Canada is rooted there first, and so that the decisions we make here at General Synod will reflect those commitments.

The Church is first and foremost the people of God: a people created by God in and for love - who gather for worship, prayer, mutual care, education and fellowship, all in preparation to be sent out into the world to share the Good News.

Jesus taught what kind of community he expects us to be. We are:

- a community where no one is more important than another (“Whoever wants to be first must be last of all and servant of all,” Mark 9.35);
- where each member loves one another as Jesus loves us (“This is my commandment, that you love one another as I have loved you,” John 15.12);
- a community that is called to unity (“so that they may be one, as [Jesus and his Father] are one,” John 17.11).
- a community called to ‘make disciples’ (“Go and make disciples”.... Matthew 28:19)

St. Paul exhorted the early church to be:

- a place where all are equal (“There is no longer Jew or Greek, there is no longer slave or free, there is no longer male or female; for all of you are one in Christ Jesus,” Galatians 3.28);

and St. Peter reminded us that:

- our primary call is to serve one another (“Like good stewards of the manifold grace of God, serve one another with whatever gift each of you has received,” 1 Peter 4.10).

In such a community:

- sharing resources for the common good of all is expected (“All who believed were together and had all things in common; they would sell their possessions and goods and distribute the proceeds to all, as any had need,” Acts 2.44-45).

St. Paul also gives us repeatedly, in his letters, a powerful central image of the church as the body of Christ with Jesus as its head, and each of us as members:

- “So, we, who are many, are one body in Christ, and individually we are members of one another.” (Romans 12.5)

This joint membership with one another and with Christ is experienced, first and foremost, when we gather around the common table:

- “Because there is one bread, we who are many are one body, for we all partake of the one bread.” (1 Corinthians 10.17)

St. Paul has crystal-clear insight into the practical implications of these convictions for the church:

- “Speaking the truth in love, we must grow up in every way into him who is the head, into Christ, from whom the whole body, joined and knit together by every ligament with which it is equipped, as each part is working properly, promotes the body’s growth in building itself up in love.” (Ephesians 4.15-16)

This is much more than a compelling metaphor – though it is that! Perhaps its most extensive working out in scripture comes in the twelfth chapter of Paul’s first letter to the Church at Corinth. Here we read of unity through diversity, of interdependence, of the elimination of distinctions between strong and weak, inferior and superior. In such a body, we acknowledge each member’s gifts, and our mutual need for them all. We each have distinctive roles to play, but we all share a common commitment.

“If one member suffers, all suffer together with it; if one member is honored, all rejoice together with it. Now you are the body of Christ and individually members of it” (1 Corinthians 12.26-27).

As Anglicans, we followed our ancestry in the Roman Catholic Church through formal structures that help us to maintain continuity, but with a reformed understanding of the synodical place of laity, clergy and bishops discerning together. We establish dioceses in a geographic area for the sake of ministry as needed in local places led by a bishop. Ecclesiastical provinces coordinate ministry for the whole of a province and connect with the wider community of other churches and the worldwide Anglican Communion as the Province of Canada.

We are a family of juridically independent but recognizably connected churches, in which each part assists the other, and which together share a common liturgical heritage and commitment to essential elements:



- Old & New Testaments
- episcopal leadership,
- the creeds (Apostles' and Nicene),
- and the two primary sacraments: Baptism & Eucharist.

Anglican structures have sought to honour unity and context. We are one family in the Anglican Church of Canada. By history and mutual commitment to the See of Canterbury we are linked with other Anglican families around the world in the Anglican Communion.

Within Canada, we make decisions together for the sake of the whole. That is not easy when our contexts differ so widely: rural and urban, isolated north and densely populated south, wealthy and not, Indigenous and non-Indigenous. But as scripture reminds us, we are called to care about all parts of our family, to help one another, and to make decisions together. Our primary purpose is not for ourselves, not even for the survival of the Anglican Church alone, but for the sake of the Good News, for building communities of faith where the Gospel of Jesus Christ may be seen and heard through our witness.

This requires deep listening to one another and a willingness to share. As a national church, we have committed to sharing resources: local to diocese, diocese to internal province and to the national church, and the national church in turn sharing through ministries both globally and locally – including redistribution of funds to support parts of the church here in Canada that need assistance. There is a circle of relationship in that sharing based on our commitment to one another: local-provincial-back to the local.

All this is a tangible expression of St. Paul's call for the stronger and larger to help the smaller and weaker – not paternalistically, but as a family with the same goals in the Gospel, and with accountability one to the other. That is why a portion of resources from the parish goes to the diocese, and a portion of that comes to the national General Synod, and a portion of that in turn is shared with the Anglican Communion. In each case, those resources serve the local level through programs, information, grants and connections.

When we hit hard times, or the kinds of extraordinary challenges we are currently facing, there can be a temptation to guard our threatened resources, to keep them for ourselves and our own. But for the Christian community, it is precisely at such times when we are called to share our joys and sorrows, and discover together that we are stronger in partnership, when we choose together how we will face the challenges. That demands transparency and honest, direct, respectful conversations – which we know are not always easy. I have been hearing those conversations across the country – diocese to diocese; parish to parish; and ecumenically.

To do this well requires trust and hard work. Trust that loving our neighbour as ourselves is at the heart of our relationship. Trust that each member is committed equally to the good of their local expression of the church, and the good of the whole expression of our church, collectively. And hard work, to make those things a daily reality.

We in the Anglican Church of Canada are entering a time of transformation. We are discerning our future mission, resetting our priorities and our strategies for achieving them, examining our governance structures, evaluating our resource requirements and opportunities, finding ways to support the emerging Self-Determining Indigenous Church, and so much more. We do all this as a church committed to being the Body of Christ, locally,

regionally, nationally and globally, as Anglicans, and in partnership with other churches – including those with whom we are in full communion. Through the pandemic we have discovered that we are resilient, creative and capable of change far more than we had thought.

I pray that as we move through this period of discernment, we will keep a core understanding of what it means to “be church” at the heart of our choices:

- We are one in Christ, siblings under God.
- We are a body of differing parts needing each other – especially as we walk together with the emerging Indigenous Church.
- We are accountable to each other, and
- We are committed to each other.
- We are called to GO AND MAKE DISCIPLES!

My friends in the Body of Christ, with God’s help, may this be so for us in our gathering in General Synod and discern God’s calling to us.

Now to reflect on the life of our Church over the past four years as I have experienced it

### **COVID & the Local Church**

The pandemic shattered all expectations and we found ourselves exiled - an exile from all that was familiar, shifting social patterns. It uncovered deep inequities we had either ignored or been blind to; raised new moral dilemmas and exposed familiar ones with greater ferocity. The biblical story of the exile in Babylon - living away from all that was familiar - resonated strongly with our experiences during the pandemic. ‘How can we sing the Lord’s song in a foreign land?’ became the lament of congregations, clergy and bishops as we looked to find new ways to engage during the exile. And we found them.

Zoom became our new best friend – and we discovered different forms of community through online engagement – It was more intimate in some ways as we could see each other’s faces! - yet distant in other ways and fully dependent on stable internet access – which is not equitably distributed. We rediscovered riches in our tradition in the daily offices as clergy and bishops began – and continue to this day – offering online daily Morning or Evening prayer or Compline. We discovered the lost practice of spiritual communion when physical communion was not possible. Yet we longed to be ‘home’ in a place where we could receive the eucharist in person. We remembered God’s faithfulness in the past and trusted that God would be faithful in the present and into the future when the pandemic was over.

During this time death was a ready companion through the physical deaths of loved ones, to the death of familiar congregational life; and the fear that it would never return. We had to listen afresh to the scriptures, to the Spirit and to the voice of Jesus and find new life rising out of our fears – see Jesus in our midst as the disciples did on the Road to Emmaus. We found resilience and hope!

We shared our worship life for the world to see and experience through online pre-recorded or live streamed worship.

As a national church we are delighted to see the Cathedrals of the ACC in the Christmas National Lessons & Carols service in 2020 and groups of youth and choirs in 2022. We discovered a new appreciation for our diversity.

As Primate I was initially at a loss as to how to engage when I could not travel to be with you in person. Soon however I discovered I could join worship with pre-recorded sermons or live streaming; I could share in smaller

groups that I would not normally be able to visit – Bible Studies; ACW groups and retreats; and Youth gatherings where participants could meet me, and we could engage in Q&A that opened up questions not normally possible in a formal parish visit or Synod.

I enjoyed teaching a course on the Anglican Communion through the Huron College Licentiate program that connected me with people across Canada. Although there was a challenge in ensuring time zones were mastered – I could actually be in several church worship services on a Sunday started moving from east to west!

Pre-Covid I traveled and shared in synods and worship across the country. During Covid I learned to do video recordings; adjust lighting; master Zoom; and listened to the advice of our communications team on improvements! – with special thanks to Lisa Barry and her staff!

COVID released its grip gradually and allowed spurts of travel though only some areas of Canada were open for visitation. I am aware that many Indigenous communities remained in full lockdown for three years and only recently have been able to open up to visitors.

In the last eighteen months I have returned to travel, to see and hear the stories of the church coast to coast to coast. A particular joy has been to spend Holy Week in one region.

In 2022 I spent Holy Week in the Diocese of Saskatchewan – including Easter in Montreal Lake with Bishop Adam; Holy Week 2023 was shared between the diocese of Yukon for Palm Sunday weekend and in the Diocese of Caledonia – in a marathon of parish services across the west side of the diocese and up the Nass Valley for baptisms on Easter Day.

I have visited Synods - provincial or diocesan – in Saskatchewan, Ottawa, Western Newfoundland, and Central Newfoundland. Wherever I travel across our Church in Canada I meet faithful Anglicans – Yes, they are engaged in worship – AND they are engaged in being communities of good news for those around them – soup kitchens and food banks; to justice advocates for the homeless; to programs for youth and children; to pastoral visiting and care; .... the list is endless!

Yes, the average demographic of our congregations tends to be over 50 and sometimes more .... but I also meet younger adults and youth engaged in their parish. We are smaller than we have been in earlier decades, but we are not gone (despite the infamous Journal headline of 2020). We remain the body of Christ – committed to one another – and committed to our identity in a wider church.

### **Key Work of the Quadrennium through General Synod**

The General Synod oversees work that connects ministry across the whole nation. Here are some highlights of the national work of the past four years.

We were able to continue the work of the General Synod through zoom meetings that, though imperfect, allowed us to make decisions in new ways. Even before COVID we selected the theme - *A changing Church; A searching World; A Faithful God* – how true that became in a few months! The Council of General Synod in particular met online – and not just twice a year as when we previously met in person – but meeting several more times as needed for particular issues and in light of the fact that long consecutive hours on Zoom is not physically or mentally helpful. We needed shorter, focused meetings. This allowed us to save resources from travel that were uncertain during COVID though government grants that sustained many parishes and dioceses through the pandemic assisted the national office too.

I want to offer a special thanks to all the members of the Council of General Synod, the Standing Committees and volunteers who thought they had committed to a triennium of three years and had an additional year added due to the cancellation of GS2022. Thank you for your perseverance and adaptability! In particular, the Planning

& Agenda Team of the Council worked hard to create both online and later hybrid meeting space that honoured the needs of all the members, kept everyone safe through COVID protocols and found ways to engage with fun to build our community together! The Spring 2022 hybrid meeting with the Trivia game was a highlight!

At the beginning of the quadrennium I asked CoGS to take a serious and consistent look at dismantling racism. Each meeting of the Council included an aspect of learning, education or reflection including the establishment of a Dismantling Racism task Force that will report to this General Synod with recommendations. Our Church is as deeply embedded in cultural assumptions that give life to systemic racism as is our society. Our leadership – clergy and lay – does not reflect the diversity of our Church. Our governance structures – diocesan, provincial and national – do not reflect our diversity. That alone should tell us that there are barriers to participation and engagement for some Anglicans. We need the voices of the whole church – all God’s people – of every race, language and nation to help us hear the Spirit in our midst. I look forward to our reflection on the Dismantling Racism Task Forces report and steps to change.

GS 2019 asked for a new strategic plan for General Synod. SPWG listened deeply across Canada – to your voices – your needs – your passion for the gospel – and discerning five aspirations ...even commitments – we want to make. As a member of SPWG I have been deeply impressed by the dedication of the team that met almost every two weeks for much of the past four years; engaged in countless zoom listening sessions with groups of Anglicans across Canada; pondered what was heard; reached out to dioceses to support their strategic planning work and proved that our Church has internal skilled resources for mission and ministry among our clergy and lay people. Their recommendations will be presented later in this General Synod for your consideration.

One result of the listening process was the re-emergence of questions around how our structures support mission and ministry in the 21<sup>st</sup> Century. An earlier report in 2013 made recommendations that have not been fully realized yet. To take a look at those questions I have initiated the formation of a Primate’s Commission - ‘Proclaiming the Gospel in the 21<sup>st</sup> Century’ – to explore the unfinished recommendations and emerging questions in relation to our national Church and bring recommendations for change to GS2025 and beyond.

We establish ecumenical relationships through the national office. I am deeply grateful for our continuing full communion friendship with the ELCIC and my friendship with Bishop Susan that encourages us to speak together whenever possible, support one another in the challenges our churches are facing; and explore issues together. You will hear more in our joint address tomorrow.

Alongside that relationship is the expanded full communion partnership through Churches Beyond Borders with the ELCA and TEC – Bishop Elizabeth Eaton and Bishop Michael Curry meet with +Susan and me twice a year for consultation and exploration of common issues – in particular dismantling racism and Indigenous reconciliation are shared concerns. I ask your prayers for Bishop Michael Curry. We had hoped he would be with us for Assembly however a medical event has meant he needs to continue rest, tests and treatment at this time. We pray for a full recovery.

At this General Synod we will consider a new full communion relationship to extend our connection with the Moravian Church in Canada. I am grateful for the opportunity to visit Christ Moravian Church here in Calgary in March this year.

We were honoured that the Archbishop of Canterbury, Justin Welby, responded to an invitation to come to Canada to share in reconciliation efforts by addressing the role of the Church of England in the early years of Indigenous & non-Indigenous relationships; in treaty negotiations and in the colonialism that led to the residential schools. With thanks to Bishop Adam Halkett for his assistance in preparations we were able to visit at the end of the Provincial Synod of Rupert’s Land so that all of the Indigenous bishops could be present. We visited the James Smith Reserve and Prince Albert – where, a few months later, there was such a tragic mass

attack and murders. The ABC listened closely to residential school survivors and offered a heartfelt apology and response. He was also able to meet survivors and leaders from Tyendinaga and Six Nations in Toronto. He has a deep concern for the relationship of the church with Indigenous peoples around the Anglican Communion and his visit with us was part of a larger commitment that included a later visit to Australia and sharing of his experience with the Lambeth Conference in August 2022.

The Sacred Circle met recently near Orillia, Ontario for the eleventh Sacred Circle. I listened, as a guest, with admiration and joy to the Indigenous Church, by consensus, affirm the Covenant and Our Way of Life documents as the foundation for the self-governing church in our midst. I heard a resilience – and strength of identity declared as every member of the Sacred Circle came forward to sign the Covenant.

These documents are clear that the gospel is in the center of the Sacred Circle. The gospel informs and shapes the life of the Indigenous church in ways that frankly, I envy. At any time during a meeting or session the gospel may be called for as needed. The meeting stops – the gospel of the day is read – and prayer is offered. The gospel is always speaking to the hearts and minds of the faithful as they discern next steps individually and corporately. This practice is one that I invite the whole church to consider. I invite us to practice it in this meeting when we need to hear the Holy Spirit in our midst through the Gospel as we discern God's call now.

We will hear more from the Sacred Circle and the Anglican Council of Indigenous Peoples in a few days here. I pray that we will receive their presentation and work with joy and commit to walking alongside, learning in ways that will challenge our whole church to grow.

This past quadrennium has also seen General Synod and dioceses face some significant internal challenges. In 2021, the handling of a proposed article for an online magazine produced by The Anglican Journal staff hurt many people, especially those who had been willing to share their experience of misconduct and how those are handled by the church or church-related institutions. The handling of the proposed article uncovered gaps in our internal systems, miscommunications between management and Journal staff and a lack of clarity in the expectations of different roles, especially in light of the resolution that reshaped our Communication Committee and created an Editorial Board in 2019. We became painfully aware of the power of social media to amplify voices – a powerful tool for justice and for partial information that caused further hurts.

An independent examination of the event and its systemic causes led to a series of commitments including:

- Clarification of the expectations of management, staff and the Editorial Board;
- Better processes for handling our mistakes that will address harms caused and deepen trauma-informed responses.

We are a church committed to being a 'Safe church' – we affirmed the Safe Church guidelines of the Anglican Communion in 2019 and committed to review our General Synod sexual misconduct policy. Each of our dioceses has committed to the review of their own policies and several have embarked on shared resources for safe church training, and independent trained investigation teams.

Nevertheless, Allegations of misconduct do and will still arise. We are committed to investigating all allegations brought forward. We are learning how trauma-informed approaches can better support complainants. We are committed to a process that holds space for a fair and just investigation as well as to completing that investigation in as timely a way as possible for the sake of all involved.

During the quadrennium one bishop relinquished his ministry following a substantiated complaint. The former National Indigenous Archbishop voluntarily resigned and relinquished his ministry after a complaint was brought forward. Although the resignation and relinquishment of ministry preempts an adjudication, we have learned that this may be unsatisfying to complainants and others.

When the process includes a cleric (deacon, priest or bishop) there is a necessary inhibition of their ministry during the investigation. This is not a pronouncement of guilt.

In light of the call for a review of our policy and under the shadow of the painful incidents in the past quadrennium several other key steps were implemented:

- i) In Fall 2022 we invited Mandy Marshall, Gender Justice Coordinator for the Anglican Communion, to visit Canada and lead online and in-person workshops on 'Becoming a Safer Church'. She offered webinars on trauma-informed responses and care; power dynamics and recognizing the signs of domestic abuse - Clergy & Laity; & diocesan Chancellors and in person sessions with the House of Bishops and the Council of General Synod
- ii) The misconduct policy was reviewed and has resulted in a revised policy that the CoGS recently received for comment. Further consultation is planned with the National Indigenous Archbishop and the Bishop of the Military Ordinariate about the revised policy. Key changes proposed to date include regular triennial reviews of the policy and an assurance that records are not destroyed but are kept, with no time limit, for all investigations.
- iii) Further Safe Church training is planned for staff and management team in addition to ongoing training for GS staff to foster and nurture a healthy working environment.

Another tragedy of the quadrennium has been the revelation of unmarked burial sites at Residential schools. The agony of Indigenous peoples across Canada poured over our country. We heard about the children who never returned home and whose families were told little or nothing about their burial sites – and continue to grapple with the ongoing discoveries as land is being investigated to learn more. Laurel Parson, our Archivist, is committed to finding whatever information may be found in burial records of nearby parishes or other archival materials to ensure it is available to families. I know that the bishops are committed to similar assistance wherever possible. We grieve with the families – and grieve for the information that may never be fully known.

Our church is not perfect. We remain committed to being a better reflection of Jesus Christ – to learning from our mistakes and failures – to repenting when we have erred and living into the grace of our redemption in Christ. I invite this gathering into a moment of silence and prayer for all who have been harmed; the pain of the legacy of our church; and our need for healing.

*Prayer: God of hope, we come before you in our brokenness and need of healing. Through your mercy and grace, we seek your forgiveness for what we have done or failed to do. Give us the courage to learn from past events, and through your Spirit give us the hope to look forward to life with you and through you, so that we may overcome the darkness and suffering surrounding us and proclaim your love in Jesus Christ our Lord. Amen.*

### **Anglican Communion**

Let me conclude with comments on the wider picture of our global connection to the Anglican Communion. We have Canadian Anglicans serving on commissions and dialogue groups across the Communion – Here are some.... Mary Wells (Safe Church Commission); Bp Joey Royal (IASCUF0); Bishop Riscylla Shaw; Dr Anita Gittens & Rev. Marnie Peterson (ACC); Bp Susan Bell (Anglican-Methodist Dialogue); Rev Gillian Hoyer (just completed term on Anglian Alliance); WCC - Bishop Riscylla; Canon Murray Still; Mr. Brendon Nielson; Rev. Dr. Preston Parsons (Pentecostal Dialogue); Canon Philip Hobson (Orthodox Dialogue); me (Science Commission/Standing Committee/ARCIC) ....Those I have missed do thou O Lord remember!

**Lambeth Conference 2022** – delayed by 4 years from its original 10 year plan for 2018 – to 2020 and 2021 then 2022. Bishops and spouses from almost all of the Provinces of the Anglican Communion gathered in Canterbury around 10 Calls ...on key areas of mission and ministry – framed not as resolutions but as Call & Response in a continuing cycle as we discern which calls are most needed in our own context and answered in a particular way

and which resonate deeply across the whole Communion

The Calls have been revised from the originals presented last summer – and are now under further discussion by Lambeth bishops' groups –

The ten calls reflect many of the priorities already known in the Baptismal Covenant, Marks of Mission and our own Strategic Aspirations. I look forward to examining how we can live into these Calls in Canada.

A particular joy for me was to experience the contrast between the last conference in 2008 and this one in the number of women bishops! 18 in 2008 – over 100 in 2022!

**Primate's Meetings** – January 2020 in Jordan, 2022 in the UK & through online zoom meetings – delighted in November to welcome a second female primate in Archbishop Marinez Bassotto, Brazil – doubly so as we were already friends from my time as Bishop of Huron through our companion diocese relationship. I have been welcomed in that body as a colleague in ministry and the relationships we build allow for frank conversation in the midst of tensions on particular issues.

Last August I was elected as Regional Primate for the Americas by my fellow primates (North, South, Central and Caribbean) to represent the Americas on the Standing Committee of the Anglican Consultative Council. This gave me the opportunity to join our delegation (Bishop Riscylla; Anita Gittens and Marnie Peterson) to the ACC in Ghana in February.

Whenever I am in international conversations it is an opportunity to witness the rich diversity of Canada – geography, theology, origins, demographics! – to share frankly about our diversity to dispel stereotypes or misinformation – especially to raise up our commitment to reconciliation with Indigenous peoples and facing our colonial past – and to speak to the strong faith in Jesus Christ I find across our Church.

It is also an opportunity to stand with our partners in the Anglican Communion – especially the Diocese of Jerusalem and the Middle East and the Province of Brazil – and support them.

**The Anglican Consultative Council** – meets once every three years – drawing on clergy and lay leaders from each Province of the Communion with the Regional Primates and Standing Committee members to consider the life of our whole Communion.

In February 2023 Bishop Riscylla Shaw, Dr. Anita Gittens and the Rev. Marnie Peterson and I attended the ACC meeting in Accra, Ghana. The richness of our Communion is experienced in that gathering through worship in all languages, bible study at mixed tables, reports of mission ministry and the needs of particular concerns from climate change to Indigenous justice to political advocacy to stories of church growth and discipleship. In Ghana we considered our need to address the history of slavery, colonialism and the ongoing crimes of human trafficking experienced in many Provinces.

**ARCIC** – One of the personal responsibilities in the wider Church I have enjoyed for over 30 years is engaging in Anglican Roman Catholic Dialogue – particularly the international commission ARCIC since 2011. In 2022 it was my privilege to act as Co-Chair for our annual meeting which included a meeting at the Vatican in Rome with Pope Francis. Our work continues on the mandate of how we discern right ethical teaching in our communions.

**Young Adult Pilgrimage to the Holy Land** – May 2023 – You will soon hear directly from a few of the 20 Anglican young adults who were selected from across Canada to travel to the Holy Land with Canon Richard LeSeuer, Sheilagh McGlynn, Andrea Mann.... It was my joy and privilege to travel with this group of young adults for the first 8 days of their journey. Diverse in many ways – yet they quickly formed into a community of disciples reflecting deeply on what they were experiencing; caring for one another; building relationships – and showing that our church is and will be in good hands as they take on further leadership.

**PWRDF & Anglican Foundation** - We are a church in partnership – particularly with PWRDF and the Anglican Foundation – to support and nurture our ministries at home and outreach needs around the globe.

It was my privilege to visit several PWRDF projects in Africa earlier this year .... To 'launch' a large water tank in a region that has seen drought for the past 3 years...and to be delighted to meet whose lives are dramatically changed by your gifts to provide water – a donkey to transport water – or a micro financing loan to expand a dairy business that allows children to finish high school and go to college. I have seen the effect of Foundation grants – sustaining infrastructure of isolated churches and rectories; & new programs for kids! These partnerships are an extension of our life as a church – both providing excellent leadership. Thank you to PWRDF and the Anglican Foundation .

Let me return to where I began.... We are gathered in this General Synod to consider the life of our national Anglican church – not your parish or even your diocese – but our life together as Anglican Christians committed to mutual interdependence and discernment of what will help us connect with each other; with other Christians; with the needs of our world; and with our siblings in Christ around the world. You are members of the General Synod, discerning together, listening to the Holy Spirit and helping us support the whole church through what is possible from the national level.

Thank you for your commitment to our life together – for taking these days away from family, parish and other responsibilities – to share in living the gospel in a family of interconnected circles from parish to diocese to Province to Anglican Communion to ecumenical partners and the whole human family.

I invite you to join me in my favourite prayer for our Church - GLORY TO GOD WHOSE POWER  
WORKING IN US

CAN DO INFINITELY MORE THAN WE CAN ASK OR IMAGINE GLORY TO GOD FROM  
GENERATION TO GENERATION

IN THE CHURCH AND IN CHRIST JESUS FOR EVER AND EVER. AMEN.
